- 1) **Call to Order and Introductions – T. Lerma - 6:10-6:20: A sign-in sheet was distributed.**

- 3) **Workgroup reports – Workgroup Chairs/Representatives**
  - a) **Resource Assessment and Evaluation – 6:30 – 6:35: Draft of resources listing was sent around the table; request was made that members send additions to B. D’Agnostino.**
  - b) **Risk and Protective Factors Assessment - 6:35-6:40: No report.**
