Communities that Care, CTC, is a prevention model that reduces youth risks, enhances protective factors and provides evidenced based prevention programs for local youth. Every two years students in grades 6, 8, 10, and 12 take the Communities that Care Survey. The results identify positive and negative risk factors among area youth. Based on these results, programs are selected and offered to the community to address needs related to teen pregnancy, violence, delinquency, school drop out, substance abuse and depression/suicide.

Baraga County CTC is made up of a diverse group of members representing youth, parents, grand-parents, business owners, educators, teachers and school staff, law enforcement, media, state, local and tribal government, health care, social services, civic groups, faith-based organizations and more. Together we serve on work groups to keep our Communities That Care efforts moving forward. CTC is made up of 6 work groups that focus on:

- Risk & Protective Factor Assessment
- Resource Assessment & Evaluation
- Community Outreach & Public Relations
- Community Board Maintenance
- Youth Involvement
- Funding
